

## EXTRACURRICULAR ACTIVITIES, CLUBS, AND ORGANIZATIONS CODE OF CONDUCT

Objective: Develop and practice ethics to promote and protect the best interest of Columbia-Brazoria ISD.

Sponsors and Coaches will encourage students to:

- Grow educationally, mentally, and physically.
- Develop good sportsmanship, sound morals, and a superior work ethic.
- Represent CBISD in a positive and dignified manner.
- Develop pride in our school and communities.
- Develop trust and confidence by practicing professional ethics.
- Be positive role models and assume leadership roles in the school and community.
- Strive for excellence in academics, athletics, and citizenship.
- Take pride in appearance by practicing good grooming habits, proper hygiene, and appropriate dress to reflect a positive self-image.
- Abide by all rules and regulations of Columbia-Brazoria ISD, the University Interscholastic League, and society in general.

Policies:

- Profanity - Profanity will not be allowed.
- Theft - Stealing from others will not be tolerated.
- Conduct – Each participant is a direct reflection of the district, conduct yourself as a sportsman at all times. Follow all rules and procedures and act appropriately in class. Show respects for staff and students at all times.
- Respect – Disrespect will not be tolerated. Sponsors and coaches should receive respect from participants at all times. Participants in turn will be treated with respect.
- Trust – Trust between sponsors or coaches and participants is a must for success. Participants must work hard to make sure this trust is not violated.
- Attendance - Coaches and sponsors must be notified if a student will not be in attendance for a class, practice or event.
- Dress - Proper attire will be worn and worn appropriately to and during all functions.
- Eligibility may be lost due to major discipline problems.
- Eligibility will be lost on the third In-School Suspension assignment during the days served.
- Eligibility will be lost during the semester of an assignment to the District Alternative Education Program.
- Students will not be allowed to miss any class they are currently failing to attend an activity or function.
- Whether on or off campus, students will abide by all rules and regulations of Columbia-Brazoria ISD, the University Interscholastic League, and society in general.
- Whether on or off campus, students will represent CBISD in a positive and dignified manner.
- Dismissal or quitting forfeits all rights, privileges, or honors earned or not yet received. Including participation in the particular activity or any other.
- Disciplinary action or suspension will be the result for failing to follow any of the above objectives, policies or guidelines.
- Student clubs and performing groups such as the band, choir, and drill and athletic teams may establish standards of behavior—including consequences for misbehavior—that are stricter than those for students in general. If a violation is also a violation of school rules, the consequences specified by the Student Code of Conduct or by local policy will apply in addition to any consequences specified by the organization.

## EXTRACURRICULAR ACTIVITIES, CLUBS, AND ORGANIZATIONS DISCIPLINE CONTINUUM

- **FIRST OFFENSE** = VERBAL REPRIMAND/WARNING/WRITTEN REPRIMAND/SCHOOL SERVICE/RESTITUTION/PARENT PHONE CALL/DO RIGHTS (CATEGORIES 1)
- **SECOND OFFENSE** = CONFERENCE WITH STUDENT/PARENT PHONE CALL (CATEGORY 1)

- **THIRD OFFENSE** = PARENT/SPONSOR CONFERENCE (CATEGORIES 1&2)
- **FOURTH OFFENSE** = PROBATION (CATEGORIES 2&3)
- **FIFTH OFFENSE** = SUSPENSION FROM COMPETITION (CATEGORIES 2&3)
- **SIXTH OFFENSE** = REMOVAL FROM PROGRAM (CATEGORIES 2&3)

### Category of Offenses

Student offenses are divided into categories according to their severity. Each category has an accompanying sequence of consequences. Consequences for disciplinary actions are based on the student's discipline history and accompanying standards. Severity of the offense or repeated offenses could result in the consequences becoming more severe.

### Category 3

#### Offenses:

- Repeated assignment to In-school Detention/ISS
- Theft/Vandalism
- Violation of probation
- Fighting/Assault
- Use/possession of alcohol/tobacco/illegal drugs on campus
- Repeated Insubordination
- Serious persistent misbehavior as defined by Texas Education Code Chapter 37 and CBISD Board Policy FOAB (Legal)
- Placement in DAEP
- Expulsion
- Drug Violations
- Indictment of Felony/Deferred Adjudication/Prosecution

***Probation***      ***A period of time not to exceed one (1) year. Any offense committed after the probationary period begins. Once the probationary period is complete, the student will placed under the jurisdiction of the regular discipline management program.***

***\*\*Suspension***      ***A period of time in which the student is suspended from participating and attending contests. Suspension periods range from 1-3 contests. Students may be required to practice during this period.***

***\*\*\*Removal***      ***A period of time in which the student is removed from their respective program. The student will not practice, play, or attend contests. The period of removal may range from the remainder of the current season of the respective program to the removal from all participation for one (1) calendar year.***

## ***Student Dismissal Procedures***

- ***For purposes of dismissal, a formal meeting will be held with the student, parent, sponsor and campus principal.***
- ***Conduct that warrants expulsion from school also warrants dismissal from program for the calendar year.***
